Mr. Joseph at 6860 Elizabeth Bethel Road was issued a Stop Work Order by the county. Mary Ann Weber is adding a horse barn addition. Mary Ann had a call that the residence at the corner of LeFevre Road and Children's Home Road may be running a cross fit business out of their barn. Teena Hensley Zoning Secretary has resigned.

Zoning meeting and workshop rates were discussed. A Motion by John R. Ryman, Seconded by William D. Sutherly to pay zoning board members \$50.00 for each workshop session they attend, and increase the Zoning Secretary rate to \$150.00 per meeting attended.
