Mr. Sutherly said Tom Maxson has taken over as care taker at Casstown Cemetery.

A Motion by William D. Sutherly, Seconded by Greg D. Dilts to allow Mr. Ryman to purchase up to \$1,000.00 including shipping for mulch from Ground Scape Maintenance. Mulching at the ETCC, EMS and township buildings will be completed by Mr. Ryman. VOTE: Mr. Sutherly-yes, Mr. Dilts-yes, Mr. Ryman-yes. John R. Ryman, President, declared the Motion carried.

Mr. Ryman said he is waiting on a Legal Opinion from the prosecutor regarding the ADA compliance requirements for the township website. Frank reported the township sign on 201 needs replaced. Mr. Dilts to research it further and report back to the board.

A Motion by John R. Ryman, Seconded by Greg D. Dilts to purchase 2 more road closed signs with stands and brackets. Amount to be determined at the time of placing order. VOTE: Mr. Sutherly-yes, Mr. Dilts-yes, Mr. Ryman-yes. John R. Ryman, President, declared the Motion carried.

The board discussed sending letters to residents who have dead trees that have the potential to fall in the roadways.

**ITEM # 9** Mr. Sutherly said he was contacted by Tom Hensley, who made an offer of \$1,000,000.00 for the Children's Home Road property. Mr. Sutherly gave Mr. Hensley and his son Mark, a tour of the facility and they thought \$30,000.00 could fix it up, with their people doing the work. Mr. Hensley asked Mr. Sutherly if they could use the facility as a boarding house for example Hobart Welding students. Mr. Sutherly said it would have to go before the Elizabeth Township Board of Appeals. There was no further contact from Mr. Hensley.

Mr. Sutherly said he and Mr. Ryman went to a meeting. The topic was regarding the tornado that went through Harrison Township on Memorial Day weekend. Mr. Sutherly said a township has no power to declare an emergency, the county has to make the declaration. Mr. Sutherly said it was challenging to organize volunteers, but the help the volunteers gave the area was over whelming.
