ITEM # 1 There was no representative present from the Miami County Sheriff's Department.

ITEM # 2 EMS-Mr. Trusty:

Continuing to work with Medicount in order for the township to receive their EMS run fees. Mr. Trusty said personnel changes at Medicount is making things difficult. Mr. Trusty said the contract with Medicount expires in March and he is researching other companies to go with. Medicount continues to blame the problem on the township not having their own FDI account, but he does not believe that to be true.

The medic should be ready for pickup November 12-15, and we will need to work out the pickup details. The board discussed keeping the old medic long enough to get the new medic up and running and then selling it on GovDeals.com.

P& R Battery quote for the hand held radios has not been received. The end of the year Budget for the City of New Carlisle is coming up. Council is to bring up pay increases at the next meeting. Current training expenses are costly. Mr. Trusty said the City will need full time fire fighters in the future.

The junk and boxes will be moved beginning tonight or tomorrow at the EMS building.

ITEM # 3 ETCC-Mr. Rice:

\$643.00 was receipted in since the last meeting. There are currently 369 members including spouses and dependents.

Proposed a membership special during the week of November 1-November 6, 2021 for 25% off memberships. An Individual Resident Membership would be \$116.25, A Family Resident Membership \$277.50, Non-Resident Individual Membership \$180.00 and a Non-Resident Family Membership \$386.25. The discount would be open to all members and new enrollments for one week and would extend current memberships by one year. A Motion by John R. Ryman, Seconded by Randy Mott to offer a 25% discount for memberships the week of November 1-November 6, 2021 for the amounts stated above. VOTE: Mr. Mott-yes, Mr. Dilts-yes, Mr. Ryman-yes. John R. Ryman, President, declared the Motion carried.

Kinley Lavender has been here 90 days and due for a pay increase from \$9.00 to \$9.50. Lisa Cozatt is due for her one-year increase from \$9.50 to \$10.00. Nic said Minimum Wage is going to \$9.30 after the first of the year. A Motion by John R. Ryman, Seconded by Greg D. Dilts to approve Kinley Lavender's increase from \$9.00 per hour to \$9.50 per hour and Lisa Cozatt's increase from \$9.50 per hour to \$10.00 per hour, effective October 30, 2021. VOTE: Mr. Mott-yes, Mr. Dilts-yes, Mr. Ryman-yes. John R. Ryman, President, declared the Motion carried.

Requested getting 18 replacement tables for the ETCC at \$94.99 from Janeco. The board requested Nic to get additional quotes for the tables. The new weights are in. The board discussed placing the old ones on GovDeals.com. Nic asked about selling them to members at the center. The board advised that they would have to go through a sealed bid process. Mary Ann suggested donating them to Miami East High School Athletic Department, as we have in the past with old equipment, they might want to use them for their athletic program. Nic said he feels the school has enough money to buy their own. A Motion by John R. Ryman, Seconded by Greg D. Dilts to donate the old weights to Miami East High School Athletic Program if they can use them. VOTE: Mr. Mott-yes, Mr. Dilts-yes, Mr. Ryman-yes. John R. Ryman, President, declared the Motion carried. Mary Ann will contact the school.

Miami East Yearbook committee asked the ETCC to purchase an ad in the yearbook.A Motion by Randy Mott, Seconded by Greg D. Dilts to place a ¼ page ad in the Miami East Yearbook for \$100.00. VOTE: Mr. Mott-yes, Mr. Dilts-yes, Mr. Ryman-yes. John R. Ryman, President, declared the Motion carried.

The board discussed the retaining wall on the East side of the ETCC is deteriorating and will need looked at in the near future, along with several rooms.

The board discussed replacing the freezer at the ETCC. A smaller freezer may be feasible, but it will need to be commercial grade. Mr. Mick suggested we refurbish the one we have. Nic will collect quotes and pricing for refurbished/new freezer for the ETCC.

- **ITEM # 5** Mr. O'Neal was absent. Mr. O'Neal received information regarding a property owner wishing to purchase the back alley on the east side of Alcony Conover from the township. Discussion of contacting other property owners who may use the alley and to contact the Miami County Prosecutor's Office for a Legal Opinion on the matter. Mr. Dilts said Frank and Dale used to cut the brush back in the past.

Mary Ann asked if the letter has been sent to the Dayton Brandt property owner, the board was not sure if Mr. O'Neal sent it.
