Mr. Ryman-shared a quote of \$14,917.82 from Small Engine Service for a 60" Hustler Mower with quick chute for the deck, this mower will be replacing the 52-inch mower. A Motion by John R. Ryman, Seconded by Randy Mott to accept the quote of \$14,917.82 to purchase a 60" Hustler mower with quick chute for the deck from Small Engine Service. VOTE: Mr. Ryman-yes, Mr. Mott-yes, Mr. Dilts-yes. Greg D. Dilts, President, declared the Motion carried. Mr. Ryman said it will take approximately 8 weeks to get the mower in.

Getting ready to trim and mulch, but will wait until Midwest has completed the ETCC project. Seal coating will be done on Saturday with a rain date of Sunday. Fiber is moving along and still being cut in. There have been good comments about the install process. Mr. Dilts said there have been some negative comments posted on Facebook. Mr. Luthman has made some unprofessional responses to the posts.

Mr. Dilts-Kirk Wolf has finished trimming and Greg will drive the roads to make sure. Water going across the road on Rudy at the Wright's. Mr. Mott contacted T.C. Holzen to get a quote for repair. Mr. Dilts said the County should be paving S. Gearhart Road soon. The board discussed paving Rudy Road next year.

Mr. Mott also asked for a quote from Holzen's to repair a hole in the road at Ruth Ann Taynor's at Chris Peeples' drive way. A steel plate was put over the hole in the road. It will be 2-3 weeks before it can be fixed. Holzen's to send quotes for both projects. A Motion by Randy Mott, Seconded by John R. Ryman to approve Bart Gessaman \$250.00 to fix the culvert on Hufford Road at Musick's. VOTE: Mr. Ryman-yes, Mr. Mott-yes, Mr. Dilts-yes. Greg D. Dilts, President, declared the Motion carried. Had a call from George Woods about a broken tile in the right of way at his place. Bart Gessaman will be contacted for a quote.
