Ryman, Seconded by Randy Mott to accept the Parcel Buy Out Release and Exhibt A for Connor Haren to buy out right 11.579 acres of the Children's Home property for \$173,285.00 as **RESOLUTION NUMBER 2022-006.** VOTE: Mr. Ryman-yes, Mr. Mott-yes, Mr. Dilts-yes. Greg D. Dilts, President, declared RESOLUTION NUMBER 2022-006 passed. Resolution 2022-006 can be found in its entirety in the Elizabeth Township Book of Resolutions.
- **ITEM # 2** Mr. Trusty-Absent. Mr. Dilts said he has been to the EMS building multiple times and there has been no one there. The equipment is there, but no staff. Mr. Dilts has reached out to Randy Bridge three different times and he still has not gotten back with him to discuss the contract.
- **ITEM # 3** ETCC- \$977.85 has been receipted in since the last meeting. There are currently 392 members including spouses and dependents. The freezer acted up briefly, but appears to be fine. - **ITEM # 6** The Meeting Minutes of the Regular Meeting of June 1, 2022 were approved as presented.
- **ITEM** # 7 Various financial reports were shared with the board. The balanced May bank rec was shared with the board. Mary Ann requested a draw from the usbank investment account to the Minster Bank checking account for General Fund expenses in the amount of \$200,000.00. A Motion by Greg D. Dilts, Seconded by Randy Mott to allow Mary Ann to make a draw in the amount of \$200,000.00 from the usbank investment account to the Minster Bank checking account for General Fund expenses when needed. VOTE: Mr. Ryman-yes, Mr. Mott-yes, Mr. Dilts-yes. Greg D. Dilts, President, declared the Motion carried. Mr. Ryman said looking back to July 2017 the change in the books for the last 5 years was a decrease of 2.5 million dollars, which included the purchase of the Children's Home property.

Mr. Mott: -The medic was picked up. Noah has completed the first round of ditch mowing. The A/C on the tractor is not working and Wagner Service is to complete the repair on the A/C. Generator at the township building is working, it appears the breaker was off. Lee Thompson from Under Lock and Key will install a combination lock to the side entry door to the township building and add a weather box to the lock at the EMS building. The above ground crypt at McKendree Cemetery needs repaired. A Motion by Randy Mott, Seconded by Greg D. Dilts to have Jeremy Paulus repair the crypt up to \$500.00. VOTE: Mr. Ryman-yes, Mr. Mott-yes, Mr. Dilts-yes. Greg D. Dilts, President, declared the Motion carried. The board discussed the preschool shed. Mr. Ryman said when do we call enough, enough with their expenses. Their monthly rental is already less than it should be at \$350.00 per month. Mr. Mott said the maintenance guys can add support to the floor of the shed to buy some time. Mr. Mott shared the final quote of \$40,000.00 from Midwest Maintenance for cleaning, spot tuck pointing, brick replacement, and lintel replacement. A Motion by Randy Mott, Seconded by John R. Ryman to accept the quote from Midwest Maintenance in the amount of \$40,000.00 for the above noted repairs. VOTE: Mr. Ryman-yes, Mr. Mott-yes, Mr. Dilts-yes. Greg D. Dilts, President, declared the Motion carried. Work will begin in September and be completed in October. Mr. Ryman said he saw the berms getting sprayed.

Mr. Ryman-No new business to discuss.

Mr. Dilts-Bunyan Tree Service came in and cut/cleaned up the big tree that fell on Gearhart Road after the tornado hit Troy. Mr. Dilts said limbs were down on Rudy and Tipp Elizabeth Roads too. Mr. Dilts thanked Sam for helping get the trees and debris cleaned up.

- **ITEM # 9** Mr. Mott said he went to the Miami County Township Association meeting last week. The Miami County Commissioners placed Electric and Natural Gas Aggregation on the November 8, 2022 ballot. Abbottsville Monuments out of Arcanum shared a granite method that can be used on the back sides of the sand stone monuments not only hold them together, but the granite can be engraved with the name and dates to make the stone readable.
- **ITEM # 10** A Motion by Greg D. Dilts, Seconded by Randy Mott, to adjourn. The meeting adjourned at 7:43 p.m.
