Mary Ann said she needs the most basic phone available. Mr. Ryman said the EMS building would not need a replacement. Mr. Mott will look into a digital version and Mary Ann will check pricing for the least expensive phone available.

Mr. Mott-Waiting to hear from ODOT on the Purchase Request. The flail mower will be sold next spring through GovDeals. Bart Gessaman completed the tile/ditch work at 780 Hufford Road at the Wood's. Received an Agreement Termination from Mrs. Berry's attorney. Mrs. Berry is requesting to terminate a previous agreement between the Berry's and Elizabeth Township for \$20,000.00. The agreement stated when Mr. and Mrs. Berry were to pass, the township would receive \$20,000.00 from the estate to maintain the Davis Cemetery located on their property for future up keep. Mrs. Berry feels due to the large sum of money the township received when Mr. Berry passed away, it should be more than enough to cover the maintenance of the cemetery in the years to come. Mr. Ryman said he has no problem terminating the contract and Mr. Mott agreed. Mary Ann asked if we should run it past Chris Englert, from the Miami County Prosecutor's Office for his input, and his supporting documentation for audit purposes before committing. Mr. Mott said he talked to previous trustees Don Hiegel and Dave Wagner, both said it was fine to terminate the agreement. Mr. Mott said he did not feel the need to ask the opinion of the prosecutor's office. A Motion by Randy Mott, Seconded by John R. Ryman to terminate the agreement dated December 6, 1989 between Mrs. Berry and Elizabeth Township as RESOLUTION NUMBER 2022-012. VOTE: Mr. Ryman-yes, Mr. Mott-yes, Mr. Dilts-Absent. Randy Mott, Vice President, declared RESOLUTION NUMBER 2022-012 passed. Resolution Number 2022-012 can be found in its entirety in the Elizabeth Township Book of Resolutions.

Mr. Ryman-Trimming/edging/mulching is complete at all three buildings.

Mr. Dilts-Change order was left for board approval from the Miami County Engineer's Office. A credit of \$5,461.50 was taken off the John R. Jurgensen Company quote for paving S. Gearhart Road. The credit was due to less materials needed to complete the job. A Motion by Randy Mott, Seconded by John R. Ryman to approve the Change Order in the amount of \$5,461.50 from John R. Jurgensen Company for the paving of S. Gearhart Road. VOTE: Mr. Ryman-yes, Mr. Mottyes, Mr. Dilts-Absent. Randy Mott, Vice President, declared the Motion carried.

ITEM # 9 Mr. Mott-Imagine Network installed Internet and a dedicated phone line for the elevator at the ETCC. Mr. Mott chose the Elite Package for the ETCC at \$94.95 per month and the phone line install was \$20.00. Nic Rice said his office internet is good, but other areas of the building are not as good.
