Mr. Mott-Surplus items have sold. Grasshopper mower sold for \$3,725.00, Rhino mower \$5,150.00 and the Boss spreader sold for \$125.00. Total Sales \$9,000.00 less commission \$720.00, net sales \$8,280.00 to be paid by Buckeye On-Line Equipment Auctions. Decals for vehicles and equipment have been received. K.E. Rose to install spreader light and spreader power unit for \$1,700.00. A Motion by Randy Mott, Seconded by John R. Ryman to accept the quote of \$1,700.00 from K.E. Rose for the install of a spreader light and spreader power unit. VOTE: Mr. Dilts-yes, Mr. Mott-yes, Mr. Ryman-yes. John R. Ryman, President, declared the Motion carried.

Mr. Ryman-Would like to set up an account with Ohio Nursery. We have some Boxwood Trees damaged, that will need replaced. A Motion by John R. Ryman, Seconded by Greg D. Dilts to allow Mr. Ryman to set up an account with Ohio Nursery. VOTE: Mr. Dilts-yes, Mr. Mott-yes, Mr. Ryman-yes. John R. Ryman, President, declared the Motion carried.

Mr. Dilts-Not sure when Rudy Road will be paved, grinding at the intersection has started. Mr. Mott said a tree was removed on Gearhart Road by Tree Care. Waiting on an estimate from Holzen's on culvert repair on Gearhart Road.

ITEM # 9 Ben Sutherly was present to tell the board he was approached by Richard King regarding his property on LeFevre Road. The farm he owns on LeFevre is in FRPP. Mr. King is requesting to swap out a ten-acre parcel that is not in the program, for a ten-twelve-acre parcel that is in the program. Mr. King is willing to give up all building rights on the ten-acre swap, if the swap is approved. The board discussed the fact that the swap would save a ten-acre parcel from being built on, so they would be in favor of the swap, as far as the township is concerned. However, NRCS has the ultimate decision of whether the swap can happen or not. Mrs. Barlow was in attendance and said if it would help get approval from NRCS, they have no problem making the ten-twelve-acre parcel, a ten-acre parcel making it an even swap. The board agreed that this would be more appealing to NRCS for approval. The board discussed that this type of request is a long process and NRCS does not make it easy to make a change. Due to the amount of time involved with the request, getting the proposal right the first time around would be beneficial for all involved. Mary Ann asked what costs and fees would be involved for the township. Mr. Mott said the land owner or in this case, Mr. King, would pay for all fees in making the swap. A Motion by John R. Ryman, Seconded by Greg D. Dilts was made to accept Mr. King's request of swapping one ten-acre parcel in the program, for one ten-acre parcel not in the program, on the condition he relinquishes all building rights on the ten-acre_swap out, with written approval from NRCS that the swap can be made. VOTE: Mr. Dilts-yes, Mr. Mott-yes, Mr. Ryman-yes. John R. Ryman, President, Declared the Motion carried. Mr. Sutherly said he would follow up with Mr. King on the board's decision.

Laura Sutherly was present to give an update on Marketing Maximizer. A blog has been written regarding using the ETCC for graduation parties in 2024. The blog will appear in the September 1, 2023 issue. The next blog will be in regard to the Craft Show in November. The first E-Blast was sent out on August 10, 2023. If someone missed the E-Blast, there will be a link they can click to read it. Job opportunities can be changed to accommodate township needs. A QR Code has been added.
