ITEM #1B Laura Sutherly was present to give an update on how the web maximizer has been utilized. There have been additional rentals May-July and positive Google reviews. Would like to upgrade the township to Marketing Maximizer for a new blog feature. Cost to go from \$325.00 per month to \$995.00 per month with additional quarterly fees of \$250.00. ITEM #2 Mr. Trusty-Absent. Mr. Blackmore presented a one year quote of \$1,053.00 for up to 18 employees for \$25,000.00 additional insurance covering, cancer, injury, medical, and Accidental Death for the part-time EMS/Fire employees through VFIS. VFIS is a nationwide company with an office in Westerville. A Motion by Randy Mott, Seconded by Greg D. Dilts to accept the quote of \$1,053.00 per year from VFIS for \$25,000.00 additional insurance as noted above for up to 18 EMS/Fire employees. VOTE: Mr. Dilts-yes, Mr. Mott-yes, Mr. Ryman-yes. John R. Ryman, President, declared the Motion carried. The board discussed a system for keeping track of EMS/Fire employee hours. It was decided that a time clock would be used. The fire chief will be responsible for calculating and submitting payroll for all EMS/Fire employees to Mary Ann, so payment of hours can be made. No applications for part-time fire chief have been received. Greg Dilts and Art will interview potential employees for the department. positions available. Tipp removed rescue 31 from their fire house and would like to store at our station; no problem providing space is available. Elizabeth Township's Station Number will be Station 45. Dr. Amburgey is interested in being our medical director. Dr. Amburgey is Tipp's medical director. Discussed purchasing shirts, hats, etc. from Western Ohio, will get quote and report back.

ITEM # 3 ETCC- Mr. Rice-\$2,207.00 was receipted in from July 19 - July 31, 2023. There are currently 327 members including spouses and dependents. \$1,600.00 of the \$2,207.00 was from the extension office for the cooking class. Faye Hayes called about the over growth of limbs and weeds in the North alley in Alcony. Mr. Mott will go look at the alley.

ITEM # 4 Bills submitted for payment totaled \$66,950.76. A Motion by Greg D. Dilts, Seconded by Randy Mott to approve the payment of bills for \$66,950.76 as presented. VOTE: Mr. Dilts-yes, Mr. Mott-yes, Mr. Ryman-yes. John R. Ryman, President, declared the Motion carried.

ITEM # 5 Mr. O'Neal-Absent-Mr. Cozatt-Spoke to Miami County Department of Development and 1455 Alcony Conover could be problematic if third owner of the property is not found. The property would need to be occupied in order for the property to be condemned, it is currently unoccupied. Approved building permit for Nancy Sparks. Had an inquiry for a garage on McCandliss. Inquiry if a mini house could be put on 2 acres on Rudy Road; not allowable by township zoning policy.

Flora Recktenwald asked Randy about getting wire fencing added around the cemeteries and would like a gate at Mann Cemetery.
