ITEM # 2 Ben Sutherly reported that he was working on the State Monitoring Report due at the end of the month. Ben said he will be following up and finishing the Federal Reporting due in February. The State program has approximately \$153,000.00 available to Elizabeth Township. Applications for the program are accepted January 18-April 18, 2024. Mr. Sutherly said he would be reaching out to the southern section of the township. Funds are dispersed by state scoring. Linda Raterman at the Miami County Soil and Water Conservation said 644 Elizabeth Township acres have been protected through their organization. That is a combined total of 6,500 acres in the township being protected. Mr. Mott said it would be nice to have an updated map that includes the Miami County Soil and Water Conservation preserved acres. Mr. O'Malley asked why target the southern section of the township. Mr. Mott said to protect ourselves from Bethel Township and New Carlisle.

ITEM # 3 Mr. Blackmore/Mr. Marchal-Absent-Mr. Blackmore reported we have a full house. Mr. Trusty was contacted that the township would accept the donation of the air compressor. Mr. Trusty to have the City approve the donation. Woodhull is to assign a sales rep to the township, to discuss copier needs. Responding into Tipp City was discussed and Tipp City would like to utilized township services into Tipp. It would create more activity for the department. Station phones are in process. Minimum Wage is going up to \$10.45 on January 1, 2024. Would like to hire Alyssa Sink at \$10.45 for front desk and cleaning. Thank you for the Texas Roadhouse Gift Cards. A request for 2 Six Month Fitness Single Memberships to the ETCC for Miami East Viking Fest was received. K.M. Ingersoll was out to fix a coil at the ETCC. It was noted that there is no annual maintenance plan in place. K.M. Ingersoll proposed having yearly service on the ETCC system, they will submit a quote for annual service. A Motion by John R. Mr. Mott received a resignation from the Commission Board and is actively looking for a replacement.
