**ITEM # 1** Mary Ann submitted payment of bills for \$124,638.55, including ACH payments. A Motion by Randy Mott, Seconded by John R. Ryman to approve the payment of bills including all ACH payments as noted for \$124,638.55. VOTE: Mr. Dilts-absent, Mr. Mott-yes, Mr. Ryman-yes. John R. Ryman, President, declared the Motion carried.

**ITEM # 2** Meeting Minutes of December 17, 2025, were approved as presented.

**ITEM # 3** Mary Ann presented **RESOLUTION NUMBER 2025-015**, as approved from the Miami County Prosecutor's Office for the participation in the 2026 QSEHRA Reimbursable Limits as set by ORC 505.601, \$6,450.00 for an Individual Plan and \$13,100.00 for a Family Plan as presented. A Motion by Randy Mott, Seconded by John R. Ryman, to accept Resolution Number 2025-015 as presented for the acceptance to participate with the 2026 QSEHRA reimbursement limits as set by ORC 505.601 as presented for \$6,450.00 for an Individual Plan and \$13,100.00 for a Family Plan. Per ORC 505.24 and ORC 507.09 Trustee Compensation for Mr. Dilts and Mr. Mott (5% increase) is \$134.41 per day x 200 days for an annual salary of \$26,882.00, Mr. Ryman (1.75% increase) x 200 days for an annual salary of \$26,050.00 and Fiscal Officer annual salary of \$35,690.00 (1.75% increase). A Motion by John R. Ryman, Seconded by Randy Mott to accept the 2026 ORC Compensation of Charts annual salary for Trustees as noted above and Fiscal Officer annual salary \$35,690.00.
