ITEM # 1A Rodney Creech was present to introduce himself as a Candidate for State Senate. Mr. Creech stated he is running for the 5<sup>th</sup> District Senate Seat, that encompasses 5 counties. Mr. Creech provided personal information and how he got to where he is today. He noted himself as a farmer, business owner, township trustee, and a county commission. Mr. Creech said he spends 85% of the time answering property tax questions. It is the topic of choice and people need to understand how important paying property taxes are to their communities. It takes time to work through something that works, only to find that it hurts somewhere else and you have to start all over again. Currently 60-74% of property tax is going to school districts in Ohio. Bexley City Schools being the highest at 74%.

To demolish the house on Alcony Conover Road the board needs to Declare it a Nuisance, and then a letter can be sent noting ORC for the demolition of the house. Spoke with Lostcreek Township regarding their policy. Mr. Englert will make a trip out to visit the house on Adams Road and see what is happening there, as trash to one person, may not be trash to another. Mr. Cozatt, Mr. Mott and Mr. Englert to meet and make the visit.

Ryman to accept Change Order No. 1 for the 2025 Asphalt Concrete Resurfacing Program as follows: Original Contract Amount was \$169,478.00, Change Order Credit of \$3,638.40, Adjusted Contract Price \$165,839.60. Limitless Hauling and Junk Removal presented a quote of \$5,900.00 to add rip rap where required to help prevent further erosion and to also add concrete at a select few catch basins, Hydro Seed for hydro seeding at \$825.00, Rip Rap in other section needed for existing sites that was talked to with John \$1,000.00 for a total of \$7,725.00. A Motion by Greg D. Dilts, Seconded by John R. Ryman to accept the quote of \$7,725.00 from Limitless Hauling and Junk Removal as noted for North Weddle Road, including hydro seeding and Rip Rap and extra Rip Rap as quoted. VOTE: Mr. Dilts-yes, Mr. Mott-yes, Mr. Ryman-yes. John R. Ryman, President, declared the Motion carried.
